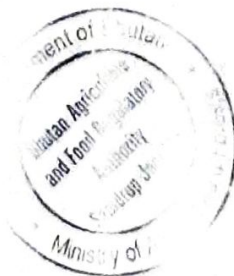

CONDITIONAL FOOD SAFETY CLEARANCE

The Bhutan Agriculture and Food Regulatory Authority (BAFRA), Ministry of Agriculture and Forests (MoAF) is pleased to issue the Conditional Food Safety Clearance for the establishment of ~~Bhutan Green Products~~ **Bhutan Green Products** (FSL-TH/19-196) in LAP-4, Plot# LSJ-55 Samdrup Jongkhar Throme under Samdrup Jongkhar Dzongkhag.

This Licence is subjected to the general terms and conditions:

- The holder shall ensure that the proposed activity is implemented in line with the Food Act of Bhutan (2005) and the Food Rules and Regulations of Bhutan (2017).
- The holder shall ensure that this License is valid only for the establishment of **Bhutan Green Products** in LAP-4, Plot# LSJ-55 Samdrup Jongkhar Throme under Samdrup Jongkhar Dzongkhag and not for any other purpose and at any other place.
- Promoter shall implement and comply with the BAFRA Criteria for **Good Hygienic and Manufacturing Practices** and intimate BAFRA office once the plant is established and before production is started for preliminary inspection.
- Failure to comply with the conditions of licensing shall be dealt as per the provisions of the Food Rules and Regulations of Bhutan (2017).
- The scope of this license is limited to Food Safety and do not touch for the clearances required by other stakeholders.
